Social/Events Team Member	An Individual over 18 years of age working as a volunteer for the association	No	\$2
Corporate Member	A business whose membership application has been accepted at a General Meeting under the conditions of the current By-Laws and has sponsored or participated in an association activity or attended a general meeting in the past two years and whose financial membership fees are up-to-date.	Yes	\$99
Not-For-Profit Member	A not-for-profit organisation whose membership application has been accepted at a General Meeting under the conditions of the current By-Laws and has volunteered for an association activity or attended a general meeting in the past two years and whose financial membership fees are up-to-date.	No	\$49
